ABA Journal

Focuses on key issues in the legal profession. Flagship publication of the American Bar Association. (Monthly) 


The Atlantic

Features groundbreaking articles on politics, social trends, education, literature, and the arts. (10 issues per year) 


Capitol Ideas

Highlights the best ideas in state government. Explores current policy issues in public sector management, economic development, education, transportation, rural concerns, energy, international affairs, and federalism. (Bimonthly) 


Child Welfare Journal

Peer-reviewed journal linking the latest findings in child welfare and related research with information on best practices, policy, and program development. (Bimonthly) 


Chronicle of Higher Education

A leading resource for in-depth information on U.S. colleges and universities. Reports on a broad range of academic topics including government affairs, international news, scholarship, and athletics. It is published in two sections: section A with news and job listings, and section B, *The Chronicle Review*, a magazine of arts and ideas. (48 issues per year) 


City Journal

One of the nation's premier urban policy magazines, it offers a mix of articles on topics ranging from school financing, policing strategy, and welfare policy to urban architecture and family policy. It also highlights the latest in urban policy theory. (Quarterly) 


Correctional Law Reporter

Summarizes the key legal decisions in corrections in a non-technical way. Issues covered include: supervised release, probation, and parole. (Bimonthly) 

Corrections Managers' Report

Written by corrections professionals, the publication offers practical guidance on how to effectively manage corrections facilities, finances, staff, and inmate populations. (Bimonthly) 


Creighton Law Review

Emphasizes legal issues impacting Nebraska and the Eighth Circuit. It includes legal articles, commentary, and case notes. Occasional special issues are devoted to a single subject matter. (Quarterly)

The Economist

Provides insight and opinion on international news, politics, business, finance, science, and technology. (Biweekly) 

Education Week

Governing

Government Finance Review

Publishes articles on a broad range of thought and practice in state and local government, finance, and financial management. Explores best practices in governmental finance. (Bimonthly) 📖

Government Technology

Covers information technology's role in state and local government. Offers in-depth coverage of IT case studies, emerging technologies, and the implications of digital technology on the politics and management of public sector organizations. (Monthly) 📖

Harvard Business Review

Highlights research and case studies focused on leadership, organizational change, negotiation strategy, operations, marketing, finance, regulatory policy, and personnel management. (Bimonthly) 📖

Health Affairs

A multidisciplinary, peer-reviewed journal of health policy and research on health reform, health care costs, and health system innovations. Journal of State Taxation

Provides guidance, information, and creative tax planning strategies for tackling problems involving state taxation. Presents comprehensive multistate taxation information in the form of both feature articles and multistate charts and tables. (Quarterly) 📖

Judicial Conduct Reporter

Summarizes recent decisions and advisory opinions, reports developments in judicial discipline, and includes articles on judicial ethics. (Quarterly) ✉

Lincoln Journal Star

Daily newspaper covering the Lincoln metropolitan area and the state of Nebraska. Also includes national and international news. (Daily) 📖

Midlands Business Journal

Spotlights businesses in the greater Omaha, Lincoln, and Council Bluffs areas. (Weekly) 📖

National Affairs

Publishes thought-provoking essays dealing with domestic policy issues ranging from economics and health care to education and welfare along with legal debates of the day and enduring dilemmas of society and culture. (Quarterly) 📖

National Review

Editorial magazine focusing on news and commentary pieces on political, social, and cultural affairs. (Biweekly) 📖

Nebraska Advance Sheets

Full text of the opinions of the Nebraska Supreme Court. (Weekly) 📖

Nebraska Farmer

Offers key information relating to agronomy, livestock, economics, management of production agriculture, and state and national legislation. (Monthly) 📖

Nebraska History

Explores Nebraska's history and culture through original articles and historical images. Features biographies, stories on political, economic, social, and ethnic issues as well as institutional and architectural history. (Quarterly) 📖

Nebraska Law Review

Publishes timely and informative articles focused primarily on law in Nebraska and the Eighth Circuit, but also includes pieces on national and international law. (Quarterly) 📖

Nebraska Life

Highlights Nebraska's culture, heritage, and natural surroundings. (Bimonthly) 📖

Nebraska Municipal Review

Features articles on laws and issues affecting local government. Of interest to both municipal leaders and anyone with an interest in local government. (Monthly) 📖

Nebraskaland Magazine

Spotlights hunting and fishing in Nebraska along with conservation, pioneer history, and in-state travel through articles and outstanding color photography. (Monthly) 📖

New Republic

Features commentary on American politics, foreign policy, and the arts. (48 issues per year) 📖

New York Times

Daily newspaper reporting on national and international news, style, and culture. (Daily) 📖

Omaha World Herald

Daily newspaper covering the Omaha-Council Bluffs metropolitan area and outstate Nebraska. Also includes national and international news features. (Daily) 📖

Pensions & Investments

Focuses on corporate and institutional investing. Features topics such as cash management, corporate finance, middle markets, and real estate. (Biweekly) 📖

Prison Legal News

Reports on a broad range of criminal justice issues and prison and jail-related civil litigation. Has a strong focus on conditions of confinement. (Monthly) 📖

Public Power

Directed toward officials of locally owned electric systems, the publication highlights innovative energy technologies and American Public Power Association activities. (Bimonthly) 📖

Public Roads

Features developments in federal highway policies, programs, research, and technology. (Bimonthly) 📖

Rural Electric Nebraskan

Geared toward rural Nebraskans, it features general interest articles such as how to reduce electricity bills. (Monthly) 📖

State Legislatures

Reports on legislation in the 50 states, best practices, the legislative process, and federal initiatives that affect the states. Contains in-depth coverage of issues crucial to state lawmakers and anyone concerned with state government. (10 issues per year) 📖

State Tax Notes

Covers taxation-related activity in state legislatures, courts, and revenue departments. Includes expert commentary, analysis, and special reports on federal tax issues. (Weekly) 📖

State Tax Review

A weekly newsletter that reports on the most current developments in state taxation. Highlights changes in laws, pertinent court decisions, and administrative rulings. Features articles from the CCH State Tax Advisory Board. (Weekly) ✉️

Stateline Midwest

Keeps members of the Midwestern Legislative Conference up to date on policy issues impacting their states, actions being taken by the region's 11 state legislatures, and work being done by the Midwestern Legislative Conference and the Council of State Governments. (11 issues per year) 📖

Time

Covers a wide range of national and international news, politics, arts, and culture. (Weekly) 📖

Vital Speeches of the Day

Provides full text of recent and historical addresses on public issues delivered by recognized opinion leaders. (Monthly) 📖

Wall Street Journal

Daily newspaper covering the world of business along with national and international news. Also publishes a supplemental magazine featuring luxury lifestyle trends. (Daily) 📖
