

STANTON COMMUNITY SCHOOLS (84-0003-000)

Chart I below is the Revenue Committee's estimate as to how the current property tax proposal would affect Stanton Community Public Schools. Any building fund levy for which the project has commenced will be grandfathered in; therefore, without knowing exactly what a school is doing with their building fund it is impossible to complete the chart accurately. The Committee is available to discuss with each district how an individual district would be effected. Below Chart I you will find **Stanton Community's Annual Finance (AFR)** report for 2018-19 (**CHART II**) which lists all general fund revenue sources to which Stanton Community Public Schools has access. It includes additional local taxes and fees, special education funding, state apportionment, etc. We have noted in red those items from the AFR that are included in CHART I. All amounts are based on statewide averages and include estimates as to probable property valuation increases in the case of commercial and residential and probable valuation decreases in the case of agriculture.
