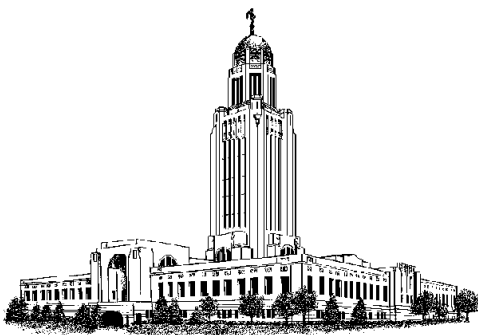

## TAX MODERNIZATION COMMITTEE PUBLIC HEARING SCHEDULE

Lincoln, NE – State Senator Galen Hadley, Chair of the Tax Modernization Committee, has released the schedule of public hearings to be held by the Committee this fall. The Committee was created during this past legislative session by Legislative Resolution 155, which requires the Committee to hold five (5) public hearings across the state on topics of tax reform.
